HEAD START ACT



Governing Body Sec. 642 (c)(1)

(c) Program Governance – Upon receiving designation as a Head Start agency, the agency shall establish and maintain a formal structure for program governance, for the oversight of quality services for Head Start children and families and for making decisions related to program design and implementation. Such structure shall include the following:

(1) GOVERNING BODY -

- (A) In General The governing body shall have legal and fiscal responsibility for the Head Start agency.
- (B) Composition The governing body shall be composed as follows:
 - (i) Not less than 1 member shall have a background and expertise in fiscal management or accounting.

Policy Council Sec. 642 (c)(2)

(A)	In General – Consistent with paragraph (1)(E), each Head Start agency shall have a policy council responsible for the direction of the Head Start program, including program design and operation, and long- and short-term planning goals and objectives, taking into account the annual communitywide strategic planning and needs assessment and self-assessment.

	(i) The policy council shall be elected by the parents of children who are currently enrolled in the Head Start program of the Head Start agency.

HEAD START PROGRAM PERFORMANCE STANDARDS



45 CFR §1301.1 Purpose.

An agency, as defined in part 1305 of this chapter, must establish and maintain a formal structure for program governance that includes a governing body, a policy council at the agency level and policy committee at the delegate level, and a parent committee. Governing bodies have a legal and fiscal responsibility to administer and oversee the agency's Head Start and Early Head Start programs. Policy councils are responsible for the direction of the agency's Head Start and Early Head Start programs.

45 CFR §1301.3 Policy council and policy committee.

(a)	Establishing policy councils and policy committees. Each agency must establish and maintain a policy council responsible for the direction of the Head Start program at the agency level, and a policy committee at the delegate level. If an agency delegates operational responsibility for the entire Head Start or Early Head Start program to one delegate agency, the policy council and policy committee may be the same body.	
(b)	Composition.	
	(1) A program must establish a policy council in accordance with section 642(c)(2)(B) of the Act, or a policy committee at the delegate level in	
	accordance with section 642(c)(3) of the Act, as early in the program year as possible. Parents of children currently enrolled in each program option must be proportionately represented on	
	the policy council and on the policy committee at the delegate level.	
	The program must ensure members of the policy council, and of the policy committee at the delegate level, do not have a conflict of interest pursuant to sections 642(c)(2)(C) and 642(c)(3)	
	(B) of the Act. Staff may not serve on the policy council or policy committee at the delegate level	
	except parents who occasionally substitute as staff. In the case of tribal grantees, this exclusion applies only to tribal staff who work in

A program must ablish a parent committee comprised exclusively arents of currently enrolled children as early in program year as possible. This committee must established at the center level for center-based grams and at the local program level for other gram options. When a program operates more in one option, parents may choose to have a carate committee for each option or combine inbership. A program must ensure that parents currently enrolled children understand the process elections to the policy council or policy committee other leadership opportunities.

	(2)	Have a process for communication with the policy council and policy committee; and	
	(3)	Within the guidelines established by the governing body, policy council or policy committee, participate in the recruitment and screening of Early Head Start and Head Start employees	



45 CFR §1301.5 Training.

An agency must provide appropriate training and technical assistance or orientation to the governing body, any advisory committee members, and the policy council, including training on program performance standards and training indicated in §1302.12(m) to ensure the members understand the information they receive and can effectively oversee and participate in the programs in the Head Start agency.



45 CFR §1301.6 Impasse procedures.

(a)	To facilitate meaningful consultation and collaboration about decisions of the governing body and the policy council, each agency's governing body and	
	policy council jointly must establish written procedures for resolving internal disputes between the	
	governing board and policy council in a timely manner that include impasse procedures. These procedures must:	
	•	
	(1) Demonstrate that the governing body considers proposed decisions from the policy council and	
	that the policy council considers proposed decisions from the governing body;	
	If there is a disagreement, require the governing body and the policy council to notify the other in	
	writing why it does not accept a decision; and,	
	decision, and,	
	(3) Describe a decision-making process and	
	a timeline to resolve disputes and reach decisions that are not arbitrary, capricious,	
	or illegal.	
(b)	If the agency's decision-making process does not result in a resolution and an impasse continues,	
	the governing body and policy council must select a mutually agreeable third party mediator and	
	participate in a formal process of mediation that leads to a resolution of the dispute.

(C)	For all programs except American Indian and Alaska Native programs, if no resolution is reached	
	with a mediator, the governing body and policy council must select a mutually agreeable arbitrator	
	whose decision is final.
